DESPITE THE CONTINUED INCREASE IN ADMISSIONS, WE RECORDED THE BEST OVERALL PATIENT OUTCOMES IN OUR HISTORY. MORE THAN 8,200 PEOPLE FROM ALL OVER THE STATE AND UPPER MIDWEST MADE MORE THAN 9,000 TRIPS TO WRC.

WRC PLAYS AN IMPORTANT ROLE IN EDUCATING STUDENTS ABOUT WILDLIFE MEDICINE.
