DESPITE THE INCREASE IN ADMISSIONS WRC CONTINUES TO ACHIEVE RECORD-LEVEL OVERALL PATIENT OUTCOMES. THE NUMBER OF PATIENTS HAS GROWN FROM 7,928 TO 13,333, A GROWTH RATE OF 68.5 PERCENT; THE BUDGET HAS DOUBLED FROM \$700,000 TO NEARLY \$1,400,000; VOLUNTEER HOURS HAVE INCREASED 65 PERCENT TO MORE THAN 67,500.
